## SHOW CAUSE NOTICE

**WHEREAS**, in terms of Section 14(1) of the NCTE Act, 1993, **MARUTI SEVA SANSTHAN ARTHUNA**, GARHI, ARTHUNA, Banswara, Rajasthan - 327032 has applied for grant of recognition to **RAVINDRA NATH TAIGORE COLLEGE**, GARHI, Banswara, Rajasthan -327032 for **B.A.B.Ed./B.Sc.B.Ed. - 4 Year Integrated** course/programme online on 31/05/2016, under Section 14(1) of NCTE Act, 1993 and received hard copy of the application in the Northern Regional Committee, NCTE on 08/06/2016

**AND WHEREAS**, Northern Regional Committee in its NRC Meeting has considered the Reply on Letter of Intent submitted online by the institution, along with hard copies and related documents and it has decided as under:-

1. There is mismatch (S.No. 1 & S.No. 14) between the faculty list uploaded on the website of the institution as on date 02.03.2019 and the list submitted by the institution for BA.B.Ed. course as required under clause 7(14) of NCTE Regulation 2014. 2. The minimum qualification of the faculty should be as per the NCTE Act for BA.B.Ed. MSLU, Udaipur has given NOC for running BA.B.Ed. programme to the institution and to run 2 units of BA.B.Ed. course, the faculty members (perspective in Education & Curriculum and Pedagogy courses) are not adequate as per NCTE Regulation 2014. Hence, show cause notice be issued under Section 14/15 (3)(b) of the NCTE Act, 1993 to the institution to submit reply within 30 days from the date of issue of show cause notice. The NCTE HQ vide letter No. 49-3/2016/NCTE/49926 dated 10.02.2017, clarified that this issue needs to be resolved as per clarification given earlier vide letter dated 7th April 2016. In this letter, we clarified that in view of another provisions in clause 8(1) of the Regulations that all standalone Teacher Education Institutions need to gradually move towards becoming 'composite-institution' the four year integrated course can also be given to a Teacher Education Institution offering a single teacher education programme, provided the affiliating university agrees to regulate the BA/B.Sc. component of the integrated programmes, as per university norms.

In view of the above, the Committee decided to issue Show Cause Notice to the institution and thereby providing an opportunity to the institution to make a written representation (both online and in hardcopy form) within 21 days from the date of receipt of the Notice along with necessary certificates/documents in order to take a final decision in the matter including rejection of application, based on the records available, with no further notice.
